

## **NAME CHANGE PROCESS**

User name in the account should always be correct and updated. If there is any change in the user name, please get this changed by completing below requirements:

1. Self-declaration on company's letter-head mentioning old name and new name, and the reason for name change.
2. An Affidavit on Rs.10 stamp paper stating the reason for name change. Details of the previous name & the new name must be clearly mentioned on the same.
3. Format (sheet 2) can be used for Affidavit and Self-declaration on Company Letter head.
4. Hard copy of ID proof of the user, Attested by Gazette officer.
5. Payment of Rs.500+18% GST= Rs. 590. Amount will be deducted from BirdRes credit limit.
